Commencement Arrives Early For Graduates

Commencement arrives early this year at Bridgewater, earlier than ever before in the history of the college. The commencement exercises proper will be conducted on Monday morning, May 1, at 10:00 a. m.

Dr. Dabney S. Lancaster, Superintendent of Public Instruction in the Commonwealth of Virginia, will be the speaker for the occasion.

The commencement season begins on Saturday evening, April 22, with the annual concert of the music department. The following weekend the season's activities will be resumed in a more detailed round of events, beginning with the customary rites of class day on Saturday afternoon. In the evening the junior class will present its play, *Whispering Walls*, a mystery of ominous proportions.

Riding An Additional Sport At Bridgewater

Three American saddle bred horses have been added to the recreational facilities of the College. Many students and members of the faculty have already indulged themselves in the equestrian art.

Two of the horses are purebred sorrels with blazed faces. Although they display plenty of spirit, they are gentle and give promise of developing into trim riding stock. Instruction is in charge of Dr. Charles C. Wright, whom President Bowman has referred to as acting professor of riding.

Riding paths will be developed across the fields and over the hills with which the College is surrounded.

Over 700 Youth on Campus at Retreat

More than seven hundred young people packed the halls and walks of Bridgewater College on Saturday and Sunday, April 15 and 16, in one of the most phenomenal responses to conference promotion in the history of the institution.

Projected as the first annual Round Table of the Southeastern Region of the Church of the Brethren, the conference had as an auxiliary purpose giving young people a first-hand acquaintance with college life.

Original expectations were that there would be two hundred to two hundred and fifty people present. When the probable magnitude of the attendance finally struck the campus, every ingenious device of accommodation known to the committee in charge was put into operation. Members of the faculty laid aside their reserve and peeled potatoes, parked cars, and generally indulged in the offices of good hosts.

The guest speaker for the occasion was the Rev. Clarence Cranford, minister of Calvary Baptist Church, Washington, D. C. He spoke twice on Saturday, first at the conclusion of a buffet supper and finally at a youth mass meeting at 8:15 o'clock in Cole Hall. Preceding the mass meeting there was a half hour organ recital played by Miss Ruth E. Weybright.

College Notes Long Service of Dr. Bowman

Speakers Laud President on Completion of Quarter Century of Service

Twenty-five years of service as a college president were recognized on Saturday evening, April 1, at a testimonial dinner in honor of Dr. Paul H. Bowman, who this spring completes a quarter century as the executive head of Bridgewater College.

Tribute was paid to Dr. Bowman both as a college president and as a civic and church leader by five of his associates in the varied fields of his interests. Representing the other colleges of Virginia, Dr. David W. Peters, president of Radford State Teachers College and of the Association of Virginia Colleges, spoke particularly of his affiliation as a student with the former Daleville College, of which he is a graduate.

Dr. Ellis Speaks

Greetings from the other colleges associated with the Church of the Brethren were brought by Dr. Charles C. Ellis, LL.D. '41, president emeritus of Juniata College, Huntingdon, Pa. Miss Ruth E. Shriver, director of children's work for the Church of the Brethren with headquarters at Elgin, Ill., represented the officialdom of the church and spoke especially in tribute to Mrs. Bowman.

Testimonials from the trustees and faculty were brought by Prof. J. C. Myers, LL.D., '42, president of the board of trustees, and Dr. J. M. Henry, '09, of the history department.

Dr. Bowman Responds

In response to this series of greetings President Bowman spoke of his long connection with Bridgewater, beginning in the aftermath of World War I. He referred jocosely to the fact that through a variety of circumstances he has been elected to the presidency several times but has never been inaugurated. He confessed to some suspicion that this occasion, which had been planned as a surprise to him, was to have been his inauguration.

In part he said, "The primary func-

Summer Session to Run For Ten Weeks

Plans are virtually complete for what will probably be the largest summer session since World War II made summer study the chief means of student acceleration at Bridgewater. The session will begin June 12 and continue for ten weeks.

Courses will be offered in almost all the fields of study in the curriculum: biology, chemistry, economics, education, English, French, history, home economics, mathematics, political science, psychology, religious education, sociology, Spanish, music, and physical education.

Four guest professors will join regular members of the staff for the session. Miss Rebekah S. Sheaffer, will give the courses in English. She is a graduate of Ursinus College, the University of Pennsylvania, and spent a year in study at the University of Cambridge. For a number of years she taught and was dean of women at Elizabethtown College.

In chemistry the instructor will be Ray A. Kurtz, who is a graduate of Elizabethtown College and the Penn-

tion of a Christian college is to discover the potentialities of human beings, free those powers of personality from their limitations and restrictions, and aid in developing the skill and technique of applying them to the ongoing of truth and right. That cause is eternal. It represents God's purpose for mankind. If there is a God, and there is, those agencies which serve those divine ends will live forever. Bridgewater College is, and always has been, devoted to those purposes."

Gifts Presented

At the conclusion of Dr. Bowman's remarks he and Mrs. Bowman were given a chest of sterling silver flatware and an album of testimonial letters. The gift of silver (International Sterling in the "1810" pattern with monogram) was made possible by the contributions of seventy-four friends, and the letters came from 122 pens.

It was announced that the contributions for the silver were far in excess of the cost of the gift, as had been hoped, and that the surplus would go toward the execution of a portrait of Dr. Bowman, which eventually will hang in the college chapel along with those of his predecessors in office.
